Convincing Evidence that all Monarchs and Courts Acknowledged.

A bronze *Arthur* in plate armour with visor raised and with jousting shield is one of the chivalrous mourners at the tomb of [Emperor Maximilian I](#) who esteemed King Arthur as one of his most noblest of ancestors. Emperor Maximilian I died in Innsbruck in 1519.

There was never a doubt that King Arthur existed among the world's courts 1300's - 1700's , who had sat and received evidence years on end of his descendants. In consideration there is only a fraction of evidence for Artaxerxes of Babylon from 500BC, and yet no one will ever dare call him or even the Spartans he fought against as "Mythical". There's even less evidence for the existance of Nero of the 1st Century and no one doubts his. Why is this? it is because we have RECORDS. The enemies of truth will only attack those of which would have the most impact for good in the world.

The ancient Welsh texts called King Arthur, the ameraudur, in Latin, "imperator" or Emperor. The linguistics of the Nott name which translates in the most oldest of languages to be the same as Emperor gives us the final key of confirmation. These dozens of items of confirmation of the Notts, from the arms, to the arrangement of the arms in Dalmatia and usage in England, to the three years of Court confirmations, to the heavy travelling of the Notts to Palestine, to Rome and to Ireland, to the extreme high prominence before, during and after the Crusades, these cannot all be drawn up to be mere coincidence and we can go with the lies that some have claimed that there are no heirs of the early Empire of Britain. Let it be settled once and for all that the British Dalmatian General of the Sarmation Knights, who was the Emperor of Britain, from the Roman Dynasty of Lucius Artorius Castus is demonstrated to be the founder of the House of Nott.

All genealogies of King Arthur himself include Constantine, again affirming his coat of arms. The more popular genealogies that include King Arthur is that of the Stuarts. Henry VII fortified his right to be King of England by his descent from King Arthur. From the time of the Crusades massive festivals and tournaments had been held to awe his court.

Arthur was more than a relic of the great crusader Kings Richard I, and Edward I, who on the eve of their departures assembled the Barons of England round the board of his ancient order to formally hand the government to their charge. Edward III launched a great revival of Arthur's Order of the Round Table at Westminster.

Strange, that in spite of Edward III's historical refoundation of the Arthurian Order on the Windsor Table

Mound and the art played by Chancellor Bishop Wykeham in its reconstruction, the authorities of to-day insist that King Arthur is a "mythical monarch," his "goodly-fellowship," the popular theme of European romance, "mere legend," and the Round Table in the Great Hall of Winchester Castle (for 400 years England's Old Parliament House) no genuine relic. The testimony of the earliest British historians, Gildas and Nennius, is ignored. The numerous references to Arthur's exploits, death and burial in MSS. (other than those of Geoffrey of Monmouth) in the British Museum, Bodleian and Cambridge libraries, we are told, are of no "historical value." Place-names and traditions go for nothing; and even the genealogies of the British kings, by virtue of which Henry VII claimed his title to the crown, are said to be "monkish inventions" and "utterly worthless" when we refer to these chronicles as proof of Arthur's personality. It was Henry Tudor's proud boast to be descended not from Norman, or Plantagenet, but from the Keltic kings Arthur and Cadwallader the Blessed, the last of his race to assume the royal title. The revival of the ancient Keltic-British element in the British monarchy, after centuries of eclipse, is a fact recorded in a striking way to Henry VII's Chapel, Westminster Abbey, where intertwined in the bronze closure round about the tomb of the founder of this magnificent mausoleum, may be seen the emblems of the House of Lancaster with those of the British King Cadwallader, the "Dragon of the great Pendragonship" of Wales. ORIGIN OF THE ARMS OF DALMATIA , NOTT , ARTHUR , CONSTANTINE , TRUE JUDAH



Being that Constantine, the first ruler of the Holy Roman Empire was born in Dalmatia, and both sides of the family were from the ruling tribe of Judah, it is believed this originated the National Coat of Arms as the lion for Dalmatia (see graphic at left). The place of exile of the last ruler of the Holy Roman Empire of the West was also Dalmatia. King Arthur also being highly known and widely accepted as a Dalmatian General of Royal lineage, was of the last Royal defenders of the Holy Roman Empire. In fact all known genealogies of King Arthur include Constantine. It is most accepted that King Arthur's arms were three golden crowns on a blue shield. The Lion in heraldry is considered one and the same with Kingship, or a crown. In England the crown is understood more than in Dalmatia with the lion. King Arthur would have indeed bore the arms of the 3 lions while representing Dalmatia. Every English King has used Lions, a symbol of Kingship. This is demonstrated as at various times of history that Dalmatia has replaced the uncrowned lions with crowned lions. Thus with all of these facts, the lion and crown are one and the same, or interchangeable.

Linguistics of the house name, as given by the Chief Royal Herold of Westphalia Germany:

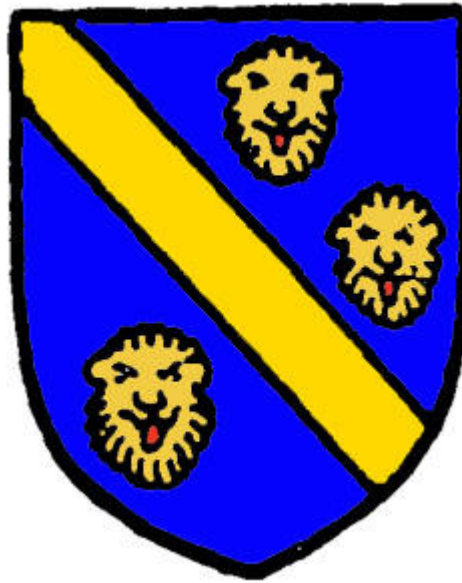
The house name is most widely excepted to be from the Danish name "Knut", it derives from the old Scandinavian name "chnout" which itself derives from old German (linuistic: Altdeutsch) "chnot, chun" which derives from Germanic "chruod" . The meaning is always the same: noble! The German and English words Koenig resp. King are deriving from the same Germanic principal form.

1911 ENCYCLOPEDIA on the term "Tsar or Czar":

"In its origin the word *tsar* seems to have connoted the same as *imperator*, being identical with the German *Kaiser* in its derivation from the Latin *Caesar*. In the old Slavonic Scriptures the Greek 1 **3aatXe**i's is always translated *tsar*, and this title was also given to the Roman Emperor. The old Russian title for a sovereign was *knyaz*, prince, or *veliky knyaz*, grand prince."

The name Nott is not a surname although later used as a surname, as it pre-dates surnames. Only the Normans implemented the surnames, while the House of Nott, were recorded to be Non-Norman, who were one of the few native-English families who retained their lands in Domesday book. We've demonstrated Nott is a noble title held by very few except Princes and Emperors. The usage of Le Notte, which pre-dates the usage of Surnames, had only one definition in the languages of that time, and that is Emperor or War Leader.

The Senior Line of (K)Nott(e)

(Note: The correct spelling is Nott. Only one member of the Knotts since the 1800's of this senior branch added a "K" in front of the name and it stuck the last 100 years. From before the 1300's the French added an "e" at the end of the name. So to not lose track of the family we will sometimes write it as "le notte" when speaking historically of that era, or just as Nott in general.)

It has been confirmed in court that these family arms of Imperial Dalmatia are also the exclusive family arms of the Successor Heirs of King Arthur(British Emperor), which is today the House of (K)Nott. After 3 long years of hearing evidence, it was proven and decided in court that this claimant to the male line of King Arthur was genuine. [\(1\)](#)

The Pedigree to the family arms is shown in the visitation of the County of Worcester, made in 1569[\(2\)](#), with notes that these are the arms of the Lord Mayor of London John (K)nott who reigned during the 1360's. He was a righteous Lord Mayor, famous for passing righteous laws and giving orders to eliminate usury. At the time, London was independent from the Crown. The Lord Mayor of London enjoyed a limited sovereignty. He had twice been Lord Mayor of London, and in prior years John (K)Nott had been the Pepperer of London (treasurer), Grocer of London, and Sheriff of London.[\(3\)](#)

A major court case in London, which ran at the same time he was Lord Mayor, affirmed that the most ancient ancestors using the (K)nott Arms (Azure, a bend or.) was from a prominent crusader family, and of descendants of King Arthur.[\(4\)](#)

Below is another Patent, this one from 1633, from Queen Elizabeth's office of Arms, confirming the ancestors at least to the 1300's.



DNA, history, archeology, heraldic practice, case law and land studies have all demonstrated the (K)Nott family was head over the prestigious families of Grosvenor (who now are the Dukes of Westminster, and richest family in the UK), Scrope, Carington, and even the Carminow family that courts confirmed were descended of King Arthur's Knights. They bore the exclusive Heraldic display, (Azure, a bend or.) a blue shield and gold diagonal stripe. The distinguishing marks being that the (K)nott's version contained three lions faces. The base design and display of it was contested and proven in court to be distinct, even during the times of the crusades. In those times all soldiers belonging to a house wore their chief's colors, but not his personal emblems upon the base shield (three lions). (5)

DNA testing was completed by a firstborn of the senior line, and it confirmed the recorded genealogies, land records, court cases, and history. It also matched with over 99% certainty with another branch of Knotts, which included the Governor (K)Nott of Virginia, who held the exact same coat of Arms. This demonstrated multiple branches of Notts were of the same house of noble lineage from the times of the crusades. This website is primarily dedicated to the senior (firstborn) line.

In the Lady chapel are the effigies of Sir Roger De Carminow (A descendant of King Arthur) and his widow Lady Johanna. Some sources say he claimed to be a descendant of King Arthur, and others, that he was descendant of Arthur's Sarmation Knights. At the beginning of the reign of James I the effigies were removed from the thirteenth century Carminow Chapel. The life size freestone is in the wall recess under the window and shows the dress and equipment of a knight of the period. The effigy is badly worn and defaced, and the illustration is partly a reconstruction based on similar monuments elsewhere.



His crossed legs reveal faith in the resurrection, and the fact he was a crusader, he was with Edward I in the last crusade of the Palestinian holy war, and in the 1296 Scottish war. he died in 1308. His Knights sword and shield display the bend of King Arthur's Knights. A small triangular shield with a plain "bend", or diagonal band.

The "le notte" family retained influence in England after the Norman invasion through marriage to the family of the Sheriffs of Warwick(later Earls of Warwick), by marrying the daughter of the brother of Thurkill (Thorkel) of Warwick, Guthmund's daughter Ailenna. Sheriff Thurkill of Warwick, who was Sheriff before and after the conquest, was son of Sheriff Alwin of Warwick. He was one of only two Englishmen holding estates of baronial dimensions directly of the King, later accredited to being founder of a Warwick Dynasty called "de Arden"⁽⁶⁾, whose branches include the de Clinton, de la Launde, de la Pecce, and le Notte families.⁽⁷⁾

It is shown in the Domesday book, that the de Ardens held more lands than any other non-Norman English family.

The Notts then multiplied into several branches holding professions predominately as priests, smiths and merchants, all bearing legendary arms of the three lions' faces. From Kent, to London, to Gloucester, to Shrewsbury. According to DNA testing those who changed their spelling to Knott are of the same ancestor as the Notts within a genealogical time frame.

From the 1100's-1300's records specifically say that younger sons and younger brothers of the Nott families took on other surnames such as "de Kington", and "Carminow", while those of the Elders of the house kept the name "le Nott". Land records demonstrate as well as clearly state this the most, while also DNA testing has given final confirmation that these records are indeed correct, yielding matches with high resolution of 99.99% certainty.

(Linguistics of this title "le Notte / Nott / Knut" is demonstrated later in this article, that it translates as: Clan Chief, or Prince, War Leader, or Emperor.)

Knights Templars of the House of Nott

Around the year 1200, it is recorded: "Thomas de Kington, brother of Henry le Notte the Elder, donated his lands in Kington (Claverdon) and in Preston Bagot to the monks" ..Knights Templar (the Fighting Order of Monks who serviced the Crusaders). This property immediately became the site of the great Templar Cathedral known as Temple Balsall.

It is recorded that in 1221 Henry le Notte donated the church houses (Advowsons, Manors and Chapels) in the surrounding vicinity of Balsall, the Church of Kington, Bickenhill, Solihull, Lyndon, Marston and Great Packington to the "Nuns" and "Monks" that were of the order of Knights Templar.

"Henry le Notte de Kintun" of Solihull gave a Grant in frank almoin to the House of the Holy Sepulchre, of an island in Kintun. Witnesses:—Roger de Oltun, Norman de Kintun, Robert Libenere, Walter Woddard, Robert Albert, and Ralph de Oltun.

In 1337 Sir John de Brumpton, Knight, gave Henry le Notte the Lordship of Manor of Eytonjuxta-Gnowsale, and paid 5 marks for license to transfer the Lordship of Longford and Advowson of the Church to Henry, which was held of the King *in capite*. (Warwickshire / Worcester area)

Henry le Notte of Solihull is recorded to have been in possession of all the greatest castles and manor houses surrounding the Temple Balsall. With the important seat of power, Marston Hall recorded as the residence of the elder house of Notts, Henry le Notte the Elder, etc.

Nicholas de Kynton, father of Richard le Notte, brought a lawsuit against sir Richard de Wodeford, Chaplain at the Warwick Convent of the Holy Sepulchre. The decision was won in his favor to forbid any from alienating any possession of the Priory.

Many of the additional titled lands of the house of (K)Nott during the time of the crusades included other great estates in the region, such as Marston Hall (now buried under Birmingham Airport), Bickenhill, Great Packington and Kington. Many of the brothers of Nott assumed the land names they held. The (K)Notte family retained ownership of these lands even after the Papal edict that all Knights Templars lands be taken, later to be given over to the Knights Hospitallers. The English Government seized nearly all Templar lands, but why let the house of Nott keep their major estates? The Order of the Holy Sepulchre continued until Henry VIII's illegal destruction. The Guild of the Holy Cross also made it through the Templar persecutions, up until Henry VIII.

The Carington family (who changed their name to Smythe / Smith in 1399 is shown by DNA testing to have a 99.999% certainty to be descendant of the same ancestor of the Notts within a genealogical timeframe, by a 35 marker high resolution match confirmed repeatedly by eight separate subjects) and these Caringtons so happened to own the adjacent estates, and also part of the Bickenhill / Balsall Templar lands. The main bordering lands being those given as reward by the King Richard I (the lion heart) to Sir Michael of Carington, who was made standard bearer for the King. He was thus rewarded for scaling the walls with four other men, and unlocking the gates at the battle of Acre in 1191. During the Knighting Ceremony and being given his rewards of Aston Hall, the family motto was pronounced by the King there on the battle field, as quoted from Psalm 112, "His horn shall be exalted". He was given such esteem for his great act of courage that Richard the Lionheart took off his crown and placed it over the helm, bearing a unicorn's head, (the family coat of arms of Carington). The Templar Carington family is also attributed as being the inheritors of the lands of Cressing Temple, the first land grant to the Knights Templars, as given by Queen Matilda in 1137. An additional land held by the Caringtons was directly attached to the Nott's territory being Wootton-Wawen, as confirmed by "the Deputies of Camden, Clarenceux, to Francis Smyth, of Wootton, grandson of Sir John Smyth, and 5th in descent from John Carington or Smith, died in 1446, who was 5th in descent from - Sir Michael Carington - Standard Bearer to Richard I - died in the Holy Land." ⁽⁸⁾ The early seat of the Carington family being Wootton-Wawen, there in the land adjacent to Preston and Kington lands, of the house of Nott. Wootton Hall continued to be held by the Carington / Smiths as late as the 19th Century, with the title of "Lord Carington, Baron of Wootton".

After the Templars were dissolved, it is demonstrated the House of Nott continued influence in the region, to later spread abroad, while always standing in the gap for Christendom in every generation unto this day. (See list below.)

Not far from this vicinity the (K)Nott coat of arms were more recently posted up in the All Saints Church of Great Shelsley where the family had become the overseers from the fifteenth to seventeenth century. The Kings Clarenceux (Chief Herald) confirmed their family lineage and coat of arms which was taken to London as Lord Mayor John Nott, and then confirmed the successors moved to Shelsley-Beauchamp, which is the neighboring area, half the distance to Great Marston.

At this same period 1587 and 1632 the lesser branches of Notts appear to have settled in Ashford Kent bearing the same arms also confirmed but with a slightly different crest and motto as below. (Note: scanned copies and excerpts of all these records, including some originals is available from the Nott library).

The le Notte family had high involvement in the founding of the "Guild of the Holy Cross", of which they gave lands, and were Proctors. (see attached refrence notes)

(Below Portrait of Lt. Col. Sir Thomas Nott, Royalist Commanding Officer, during the great revolution, known as the English Civil War from 1641-1651. He was most esteemed for his learning and genteel accomplishments, was elected a fellow of the Royal Society and served as Usher-in-Ordinary of the Honorable Privy Chamber to King Charles II. One of the Last Effectual Advocates of the Divine Right of Kings.)

A more recent pedigree going back to Sgt John Nott of 1615/18 born in Bristol England, was verified and confirmed by the staff of Sir William Arbuthnott, and the Hon Keith Arbuthnott, Rt Hon, the Viscount of Arbuthnott, KT, DSC which pedigree can also be found online at the following address, <http://www.kittybrewster.com/Nott.htm> (at the Arbuthnott Family Association Website), mainpage: <http://www.arbuthnot.org/index.htm>; Just another source further demonstrating the house is the senior branch of the Knotts, and additionally since 1618 until this present day. In primogeniture law seniority is descending

only of firstborns. This line is well documented.

The Firstborn line was of John Nott, who had the title Sgt John Nott when he came to America and settled in Connecticut in 1635. In those days the rank of Sergeant was more like a rank of Captain today. One of his younger cousins remained in England as "the Parson Charles Nott of Shelsley Beauchamp". As all the family are listed in genealogy documents of our line held in their name the title: "Nott **of Shelsley Beauchamp**", as is given in the 1924 publication "A History of the County of Worcester" where it is explained why the name is "Nott of Sheldesly Beauchamp".

This Charles Nott of Shelsley Beauchamp was so prestigious among the population that he won the most acclaim as being the leader of a band of 1,000 light armed "clubmen" whose sole purpose was to defend the women, children and neighboring towns from the civil war armies raping and pillaging. He is given credit as the greatest leader of the Clubmen movement. As at this time of 1645 there were major wars going on between the Parliamentarians and the Royalist camps. The Clubmen were all neutral, only doing the most noble of tasks, protecting their towns against armies.

There have been many other great Captains, Generals, and other great leaders of the House of (K)Nott descended of this most noble of lines. Here is a brief list:

NOTABLE DESCENDANTS - DIRECT ANCESTORS OF THE HOUSE OF NOTT

- (confirmed) **Saint Helena, Mother of Constantine**, born in Britain in circa 246-250, established numerous churches in Palestine.
- (international recognition undisputed) **Emperor Constantine the Great**, Caesar, Nott, King of Britain, born Dalmatia 272, Roman Emperor, the Christian Emperor, Byzantine Emperor, King of Israel, Heir of Judah, King of Palestine. Built Saint Helena's Church at Bethlehem, and in remembrance of his cousin St. George, the Governor of Palestine who was martyred there, over his tomb he built the Temple at Lydda and the Cour de Lion's Church.
- (court confirmed and undisputed) **King Arthur** (Historians most widely accept him as a Dalmatian General-King. English courts confirmed King Arthurs's Arms, with arms of Dalmatia were exclusive, and registered to the Nott family.) Every Celtic Kingdom of the 6th century said he also was their King.(9)
- (confirmed) **King Cerdic of Wessex, the Welsh translation of Cerdic is "Strong Arm". It has been proven he was Arthur.** The Latin and English translations of Ceredig Vreichvras are Coroticus Artus and Cerdic Strongarm. History shows Cerdic was a Celtic/British ruler over the Saxons, with much Knightly activity abroad, just as his grandparents were in Palestine, Rome, etc. If there is any truth at all to the history of Arthur, then Cedric would be his prime descendant, the founder of the House of Wessex. - (confirmed) **House of Wessex from Cerdic-Arthur to Dux Alfwold** [click here](#)
- (confirmed) **King Edmund** (Saint and Martyr killed in 946AD) Worcester Cathedral displays his coat of arms, the three golden crowns on the blue shield, of King Arthur. This primogeniture inheritance passed down the line.
- (confirmed) **Dux Ælfwald** son of [Æthelstan Half-King \(East Anglia\)](#). In Domesday book, the records of King Athelstan in 966 [confirming his 1,200 acres of Kinton, originally spelt Cynton, which could be translated as Cyn, meaning king and ton, meaning manor \(King's Manor\)](#). And confirmed 5,400 additional acres held of him in Witney, Oxon and Apsley Guise, Beds.
- (confirmed) **Queen Emma of England, Normandy, and Denmark**, the last Surviving Monarch of the House of Wessex, with title of the line of to King Arthur and Constantine.
- (confirmed) **William Cnut(Nott), Grandson of Emma, the illegitimate son of Hartheknutr**, inherited lands of Kinton from his Uncle King Edward the Confessor, but called illegitimate and could not be consecrated as King. In the region William Nutte was recorded in the Northamptonshire Pipe Rolls dated 1181.

- (confirmed) **Milo de Kineton**, provided a Manor house in Kynton to the Kenilworth monks in circa 1140-1150
- (confirmed) **William Notte, Captain** in the Norman invasion of Ireland 1169-1177, serving under the Earl of **Pembroke**. (He or his father was known as **William Nutte the church builder in the echequer pipe rolls of Northhamptonshire**).
- (confirmed) **John de Kinton** in about 1170 gave Reading Abbey land in Bearley and 'Azceals' or 'Echles' which he had of the gift of William, Earl of Warwick; its bounds are given as from Chelewellesiche to Pauenhale, thence to Allrensiche, thence to the road coming from Warwick, and by the road to the cross and Codesturne (in Preston Bagot). (fn. 46) The grant was confirmed by Earl Waleran. (fn. 47) Gerard son of William de Burle also gave land here, his gift being confirmed by his father and by John de Burle, (fn. 48) his uncle. (fn. 49) These holdings probably became attached to the abbey's manor of Rowington (q.v.).
- (confirmed) **Henry le Notte**, maternal line descendant of the Earl Sheriff Alwin of Warwick at the Conquest (the de Arden family), and through this relation to the Norman Invasion era Sheriff, was able to retain many estates after the conquest, including Great Packington, the estates of William fitzAnsculf, the Marston Hall Estate, and what remained of the ancestor Guthmund's estates in Kington. It is recorded that in 1199 he acquired 1 virgate of Kineton Green (KINGTON) from Richard, son of Richard, (fn. 213) probably his brother. In 1211 he sued Hugh fitz Peter of Bushberry for a considerable ammount of the land of Bushbury and Penn which the Nott family claimed were sole inheritors through the ancestress Aillena, daughter of Gudmund, with the Pedigree filed in court. (fn. 214) In 1221 he gave to the Prioress and convent of Markyate (Beds.) the advowson of 'the church' of Kington, (fn. 215) though this is subsequently ranked with the chapel of Lyndon as a chapel attached to the church of Bickenhill, (fn. 216) which the nuns held. He's recorded as giving the entire Bickenhill church (of St. Peter) to the Nuns. It contained a Church, Middle, Lyndon, and Marston Quarters with 774 inhabitants, this church included Kington or Kingsford , partly in this parish and partly in Solihull. He successfully claimed dozens virgates of land in the Solihull region by right of ancestry.
- (confirmed) **Thomas de Kington, brother of Henry le Notte**, about the year 1200 "donated his lands in Kington (Claverdon) and in Preston Bagot to the monks", which is the site of Balsall Temple of the Knights Templars. Still a great Preceptory and Templar Cathedral stands at the site.
- (confirmed) **Nicholas de Kinton, father of Richard le Notte**, was seised as of fee when he died, of two acres of **land** and one and a half acre of pasture in Thisho, which Basilia de Stafford holds. A concord was made by which Richard released his claim. *m. 1* From the Warwick Assize Roll, *Warw.* (1221-1222)An assize, etc.
- (confirmed) **Richard le Notte de Kynton** in 1303 granted **"the Fraternity of the Gild of the Holy Cross" of 2d. annual rent out of a messuage in le brugge stret**, between the tenements formerly held by Robert de Brome and Juliana de Dumbeltone. He is recorded as paying for assizes to the Sheriff of Warwick. He held land in Kington and Kingsford of William de Ryfeld and Margery his wife, who remitted on her behalf the rent, homage, and service of 1/100 knight's fee by which it was held in 1271; (fn. 218) **(the Abbey of the Gild of the Holy Cross is Pembroke Abbey. A very lively and fully functioning abbey as of 2010.)**
- (confirmed) **Thomas Notte, Proctor to the Gild of the Holy Cross** etc. of Stratford upon Auen in 1305 and 1314 conveyed lands in Solihull and Kington to his son Henry. (fn. 219) This Henry in 1332 settled lands in Kington and Lyndon on himself in tail, with contingent remainders to **his son John**, or John's sister Prudence. (fn. 220) In Domesday book, spelled "Cintone" probably.
- (confirmed) **John, son of Henry de Kinton**, in 1272 sued Magister Henry le Teynturer for a messuage and half a virgate of land, and one-third of a virgate in le Wal-extra-Lichefeld. (Plea Rolls of Edward III)
- (unconfirmed) **Gilbert le Nott** in 1309 Attorney to King Edward II, Commissioned to Ireland for two years.
- (confirmed) **Henry le Notte de Kintun, Lord of Solihull** gave a Grant in frank almoin to the House of the Holy Sepulchre, of an island in Kintun. Witnesses:—Roger de Oltun, Norman de Kintun, Robert Libenere, Walter Woddard, Robert Albert, and Ralph de Oltun. 1337 Sir John de Brumpton, Knight, gave him the Lordship of Manor of Eytonjuxta-Gnowsale, and paid 5 marks for

license to transfer the Lordship of Longford and Advowson of the Church to Henry, which was held of the King *in capite*. (Warwickshire / Worcester area)

- (unconfirmed) **John Nott of Lench**, Rector of Lench, Was presented as Rector directly by the Earl of Warwick, Thomas de Beauchamp, and with Lord Goure, and the Marshall of England, to the church of Lench Roculfe, 8 Jan. 1361.
- (confirmed) **Lord Mayor of London**, John Nott 1363, he also had been the Pepperer of London (treasurer), Grocer of London, and Sheriff of London.
- (confirmed) **Lord John Hugh Nott**, Lord of the Manor of Great Sheldesly born 1490. Confirmed by the Clarencieux of arms as successor to the Lord Mayor of London.
- (confirmed) **Catherine Walsh-Nott**, sister of Sir Walter, Groom of the Privy Chamber to Henry VIII, and to Sheriff of Worcester, Married Lord of the Manor of Great Sheldesly John Nott born 1490.
- (confirmed) **John Nott of Great Sheldesley**, born 1520, Recipient of Arms transfer by Clarenceux Cooke, King of Arms in 1575, confirmation from the Clarenceux as being the legal inheritor of the arms of the Lord Mayor of London John Nott from 1363.
- (confirmed) **Lord John Nott** Lord of Great Sheldesly, born 1585, married Anne Geffries of Homme(/Holme/or Ham) Castle, which was fortress under great siege by Sir Oliver Cromwell. He sold the Capital Messuage of Great Shelsley, and the advowson of the church in 1653 to John Travell of London.



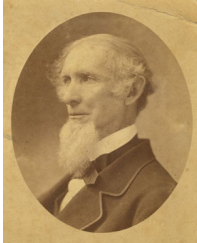
- (confirmed) **Lt. Col. Sir Thomas Nott**, born 1606, Royalist Commander during the Great Revolution (the civil wars), Gentleman Usher-in-Ordinary of the Honorable Privy Chamber to his present majesty King Charles II.
- (confirmed) **Sgt John Nott** of Wethersfield Connecticut Commander in various Indian wars 1635 forward, a wealthy land owner, Representative of General Court of Connecticut till 1682.
- (confirmed) **Parson Charles Nott of Shelsley-Beauchamp**, famous in 1645 as the leader or "Parson" of the Clubman movement, at head of a band of 1,000 Clubmen against two armies, protecting the villages against pillaging armies.
- (confirmed) **Commander William Nott**, US Navy Captain during the war of Independence, reported directly to the Commander-in-Chief and to the Governor of Connecticut. Had captured many enemy British vessels.
- (confirmed) **His Excellency Governor Edward Nott**, Governor of Virginia. Died 1702, Monument with the family arms erected.
- (confirmed) **The Rev. Abraham Nott**, Yale Graduate D.D., Pastored Congregational Churches for 34 years, died in 1759.
- (confirmed) **The Rev. Dr. Samuel Nott**, Yale Graduate D.D. Styled "Patriarch of the New England Clergy." Regarded as one of the most successful educators of his day. Pastored Congregational church of Franklin Connecticut for 71 years.
- (confirmed) **Thomas Nott**, volunteer Infantryman , 3 years during war of Independence, was not accredited for service.



- (confirmed) **Dr. Eliphalet Nott**, President of Union College, writer of "Providence of God Toward American Israel" 1810.



- (unconfirmed) **Major General Sir William Nott**, born 1782, Commander of the Army of Candahar, Afghanistan and Envoy at the Court of the King of Oude. (Born in general area of House of Nott ancestors.)
- **Congressman and Judge Abraham Nott, Esq.**, Born in Saybrook Connecticut 1768. Died in South Carolina 1830.



- (confirmed) **Dr. Josiah C. Nott**, writer of "Types of Mankind" 1854, the most concrete proof against Darwin's theories on race. His father was Abraham, born in Connecticut, from this main branch of Notts in America.



Charles C. Nott

- (confirmed) **Chief Justice Charles Cooper Nott**, appointed by Abraham Lincoln to the US Court of Claims, President Cleveland appointed him as Chief Justice. He was grandson of Eliphalet Nott.



- (confirmed) **Congressman Clarkson Potter-Nott**, Twice Elected to Congress in New York, (Served from March 4, 1869-March 3, 1875).
- (confirmed) **George (K)Nott-Brunswick**, Engineer, solved and developed first stable intermediate-range missiles in the 1950's. He was congratulated for this achievement by the US Chief of Aerospace, Wernher von Braun.



- (confirmed) **The Reverend S. Michael (K)Nott-Brunswick** as of 2009 sits in exile in the Netherlands. Retired Militia Minuteman Commander, firstborn of the firstborns (primogeniture male), Scion of the house of Nott. His arms were again registered in Germany for his office of Bishop, now also acting ArchBishop, Benelux Jurisdiction. *(His potential living titles of Sovereignty, which he is advised has the legal possibility to claim, and to set up a Constitutional Monarchy, include:* ***His Highness, the Prince of Brunswick, the Duke of Brunswick, of the Dukedom of Brunswick-Wolfenbüttel, the Prince of Bevern, the Prince of Blankenburg, the***

*Prince of Stettin, the Prince of Oels, the primogeniture Head of the house of Welf [Europe's oldest living de jure Sovereign Royal House], Grandmaster of the Knightly orders of Brunswick, a Count and Lord in dozens of Countships and Lordships and Principalities within Brunswick, Prince of living sovereign holdings outside of Brunswick, including the **Principality of Oels Poland, Principality of Stettin Poland**, [currently maintained by the houses of Saxony and Hohenzollern], **Hereditary Feldmarschal of Austria** [Maintained by numerous successors], **the Lord Marshall of England** [through DNA testing with descendants of the Earls of Pembroke, maintained by the Norfolk descendants], **Emperor of the Kingdoms of Great Britain** [Maintained by the Windsors and other continuous de jure Sovereigns], and many other titles of inheritance, still maintained by living de jure sovereignty; all of which are only under advisement at this stage.)*

ORIGIN OF THE ARMS OF DALMATIA , NOTT , ARTHUR , CONSTANTINE , TRUE JUDAH



Being that Constantine, the first ruler of the Holy Roman Empire was born in Dalmatia, and both sides of the family were from the ruling tribe of Judah, it is believed this originated the National Coat of Arms as the lion for Dalmatia(see graphic at left). The place of exile of the last ruler of the Holy Roman Empire of the West was also Dalmatia. King Arthur also being highly known and widely accepted as a Dalmatian General of Royal lineage, was of the last Royal defenders of the Holy Roman Empire. In fact all known genealogies of King Arthur include Constantine. It

is most accepted that King Arthur's arms were three golden crowns on a blue shield. The Lion in heraldry is considered one and the same with Kingship, or a crown. In England the crown is understood more than in Dalmatia with the lion. King Arthur would have indeed bore the arms of the 3 lions while representing Dalmatia. Every English King has used Lions, a symbol of Kingship. This is demonstrated as at various times of history that Dalmatia has replaced the uncrowned lions with crowned lions. Thus with all of these facts, the lion and crown are one and the same, or interchangeable.

Linguistics of the house name, as given by the Chief Royal Herold of Westphalia Germany:

The house name is most widely excepted to be from the Danish name "Knut", it derives from the old Scandinavian name "chnout" which itself derives from old German (linuistic: Altdeutsch) "chnot, chun" which derives from Germanic "chruod" . The meaning is always the same: noble! The German and English words Koenig resp. King are deriving from the same Germanic principal form.

1911 ENCYCLOPEDIA on the term "Tsar or Czar":

"In its origin the word *tsar* seems to have connoted the same as *imperator*, being identical with the German *Kaiser* in its derivation from the Latin **Caesar**. In the old Slavonic Scriptures the Greek **3aatXeи** is always translated *tsar*, and this title was also given to the Roman Emperor. The old Russian title for a sovereign was *knyaz*, prince, or *veliky knyaz*, grand prince."



A bronze *Arthur* in plate armour with visor raised and with jousting shield is one of the chivalrous mourners at the tomb of [Emperor Maximilian I](#) who esteemed King Arthur as one of his most noblest of ancestors. Emperor Maximilian I died in Innsbruck in 1519.

There was never a doubt that King Arthur existed among the world's courts 1300's - 1700's , who had sat and recieved evidence years on end of his descendants. In consideration there is only a fraction of evidence for Artaxerxes of Babylon from 500BC, and yet no one will ever dare call him or even the Spartans he fought against as "Mythical". There's even less evidence for the existance of Nero of the 1st Century and no one doubts his. Why is this? it is because we have RECORDS. The enemies of truth will only attack those of which would have the most impact for good in the world.

The ancient Welsh texts called King Arthur, the ameraudur, in Latin, "imperator" or Emperor. The linguistics of the Nott name which translates in the most oldest of languages to be the same as Emperor gives us the final key of confirmation.

These dozens of items of confirmation of the Notts, from the arms, to the arrangement of the arms in Dalmatia and usage in England, to the three years of Court confirmations, to the heavy travelling of the Notts to Palestine, to Rome and to Ireland, to the extreme high prominence before, during and after the Crusades, these cannot all be drawn up to be mere coincidence and we can go with the lies that some have claimed that there are no heirs of the early Empire of Britain. Let it be settled once and for all that the British Dalmatian General of the Sarmation Knights, who was the Emperor of Britain, from the Roman Dynasty of Lucius Artorius Castus is demonstrated to be the founder of the House of Nott.

The name Nott is not a surname although later used as a surname, as it pre-dates surnames. Only the Normans implemented the surnames, while the House of Nott, were recorded to be Non-Norman, who were one of the few native-English families who retained their lands in Domesday book. We've demonstrated Nott is a noble title held by very few except Princes and Emperors. The usage of Le Notte, which pre-dates the usage of Surnames, had only one definition in the languages of that time, and that is Emperor or War Leader.

All genealogies of King Arthur himself include Constantine, again affirming his coat of arms. The more popular genealogies that include King Arthur is that of the Stuarts. Henry VII fortified his right to be King of England by his descent from King Arthur. From the time of the Crusades massive festivals and tournaments had been held to awe his court.

Arthur was more than a relic of the great crusader Kings Richard I, and Edward I, who on the eve of their departures assembled the Barons of England round the board of his ancient order to formally hand the government to their charge. Edward III launched a great revival of Arthur's Order of the Round Table at Westminster.

Strange, that in spite of Edward III's historical refoundation of the Arthurian Order on the Windsor Table Mound and the art played by Chancellor Bishop Wykeham in its reconstruction, the authorities of to-day insist that King Arthur is a "mythical monarch," his "goodly-fellowship," the popular theme of European romance, "mere legend," and the Round Table in the Great Hall of Winchester Castle (for 400 years England's Old Parliament House) no genuine relic. The testimony of the earliest British historians, Gildas and Nennius, is ignored. The numerous references to Arthur's exploits, death and burial in MSS. (other than those of Geoffrey of Monmouth) in the British Museum, Bodleian and Cambridge libraries, we are told, are of no "historical value." Place-names and traditions go for nothing; and even the genealogies of the British kings, by virtue of which Henry VII claimed his title to the crown, are said to be "monkish inventions" and "utterly worthless" when we refer to these chronicles as proof of Arthur's personality. It was Henry Tudor's proud boast to be descended not from Norman, or Plantagenet, but from the Keltic kings Arthur and Cadwallader the Blessed, the last of his race to assume the royal title. The revival of the ancient Keltic-British element in the British monarchy, after centuries of eclipse, is a fact recorded in a striking way to Henry VII's Chapel, Westminster Abbey, where intertwined in the bronze closure round about the tomb of the founder of this magnificent mausoleum, may be seen the emblems of the House of Lancaster with those of the British King Cadwallader, the "Dragon of the great Pendragonship" of Wales. 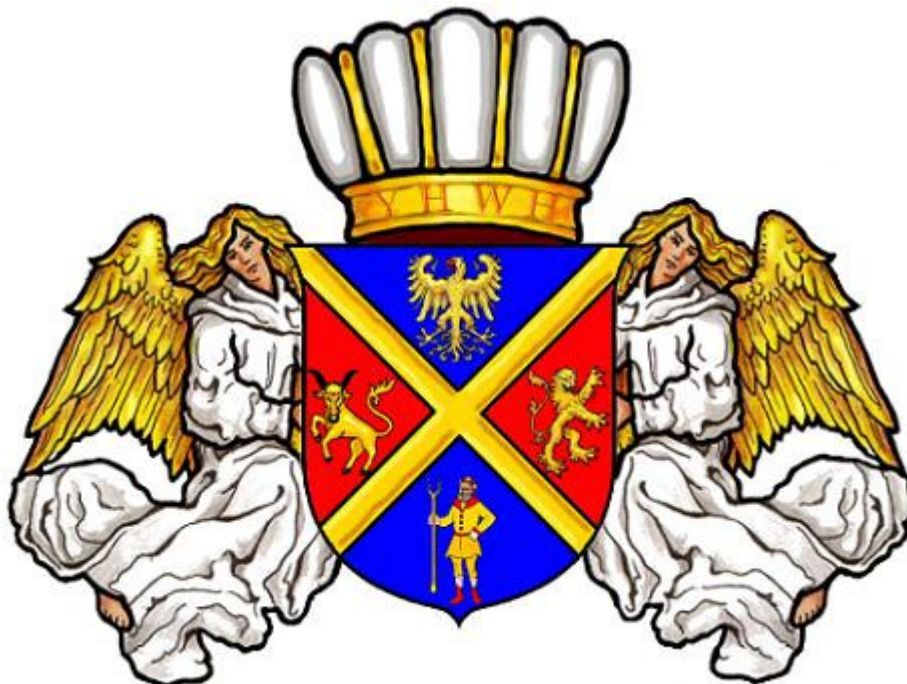
